14. Board Office safety.

Ms. Alldredge requested a motion to return the exam fees that CABI's had sent in for June 2015 exam, and to mail out a postcard to all CABI's, LaBAs and LBA's notifying them of this change. After a discussion with Dr. MacAleese, it was decided to deal individually with exceptions. After a lengthy discussion it was decided to table this for further discussion for all Board members to look at NRS 641.390 and have a further discussion at the next Board meeting to discuss the need for further clarification in NAC 641.

19. Correspondence

A. Rachel Davis; Requesting approval from Board regarding providing Supervision.

Dr. Davis wrote to the Board asking that the Board approve her ability to supervise interns, requesting her credentials as acceptable in regard to meeting the requirements of NAC 641. Dr. Paul motioned to approve Dr. Davis' request to provide supervision at CARD for interns. Dr. Ghezzi second. Board Vote 5-0-1. Dr. Lenkeit recused. Dr. Paglini no longer on the phone.

B. Shweta Sharma; Foreign applicant requesting assistance from the Board.

Dr. Sharma wrote to the Board in regard to the review and acceptance of her non-APA education. She suggested the following two alternatives:

1-The Board recommend qualified individuals or organizations to evaluate her non-APA education.

2-The Board provide her with an opportunity to appear in examinations to evaluate her qualifications.

It was decided by the Board to refer Shweta Sharma to AEQUO International, an organization that handles foreign applicants.

C. Kathlyn Tipton; Request for clarification and direction in providing services.

Dr. Tipton wrote to the Board informing the Board that she is considering expanding her services to include basic education consultation. Dr. Tipton highlighted 3 areas, in her letter, that she would be including in her new practice. One of the highlighted areas dealt with using school assessments or other diagnostic assessments provided by the family, for designing intervention. It was decided that the Board would write her a letter stating that under NRS 641.390 she cannot call herself a Psychologist in her private practice, nor can she make or determine assessments.

20. Public Comment.

Ms. Dailey requested to make comment concerning the dismissal of Complaints 15-0401A and 15-0401B. She requested more information regarding the appeals process for complaints. Requesting the Board reconsider the dismissal. Mr. Dailey began to request the Board table the decision until the full Board can review the information. Ms. Bradley informed Mr. and Mrs. Dailey that a complaint may only be reopened if new information, not included with the original complaint, is presented to the Board office for review. Ms. Bradley also continued to explain the Board's current complaint evaluation process. Mr. Dailey continued and became aggravated. Both Mr. and Mrs. Dailey had exhausted the allotted 3 minutes each. Dr. Lenkeit chose to end public comment at that time.
