**2. Public Comment**

No public comment.

**3. Approval of minutes of previous meetings;**

There were no prior minutes to review.

**4. Treasurer's report for F/Y 2016-2018.**

Dr. Owens was absent; Ms. Gleich reviewed the P & L and Budget. It was noted that expenses from January were higher due to legal bills from November's hearings, and travel expenses for the January retreat, with the expenses in February were much lower. Dr. Krogh requested an update regarding the budget. Dr. Wood-Antonuccio motioned to approve the treasurers report, Dr. Krogh second; Board 5-0-0

**5. Review of complaints, disciplinary actions, and litigation pending.**

- A. **Complaint #16-0919** – Complaint settled, however still pending, left on the agenda in case of future review. Requested to be listed as a separate item on the Agenda to allow the Board to give future updates.
- B. **Complaint #16-1005** – Complaint settled, however still pending, left on the agenda in case of future review. Requested to be listed as a separate item on the Agenda to allow the Board to give future updates.
- C. **Complaint #17-0710** – Settlement agreement presented to Board under item 6. Board reviewed the Proposed Stipulation for Settlement; Settlement has been signed; Dr. Wood-Antonuccio made a motion to dismiss; Ms. Becker second; Board 5-0-0
- D. **Complaint #17-0717** – During the review of the complaint, Dr. Lenkeit made request for clarification from both the complainant and the psychologist in question. Complainant has not responded to requests

for more information. In discussion with the complainant's attorney Dr. Lenkeit received verification that many of the items did not happen. Upon review, Dr. Lenkeit did not feel the Psychologist violated any ethical or legal ethics. Dr. Young made motion to dismiss; Dr. Krogh second; Board 5-0-0  
Upon discussion of the facts of the case being concerning it was motioned by Dr. Wood-Antonuccio and seconded by Dr. Paglini that if upon Ms. Bradley's review of the law and consultation with colleagues that Dr. Lenkeit contact the Judge involved regarding the allegations and complaint filing. Board vote 5-0-0.

- E. **Complaint #17-0824** – Dr Young in review of the complaint felt this was filed in retaliation regarding other events currently under investigation by the Board. Dr. Young would like to interview psychologist regarding other open complaints. Dr. Young would recommend for dismissal. Dr. Wood-Antonuccio made a motion to dismiss; Dr. Krogh second Board 5-0-0
- F. **Complaint #17-0911** – Upon review of the complaint by Dr. Young, it was found that the complaint's allegation cannot be substantiated, as there were two other persons in the room who deny the allegations. Dr. Young recommends for dismissal. Dr. Wood-Antonuccio made a motion dismiss; Dr. Krogh second Board 5-0-0
- G. **Complaint # 17-1011** – Upon review of the complaint by Dr. Young, it was found to have no basis. It was heard in court five days after the receipt of the complaint in the Board office. Dr. Krogh made a motion dismiss upon further evidence that supports the claims were heard in court on October 16,2018; Dr. Wood-Antonuccio second; Board 5-0-0
- H. **Complaint # 17-1023** – Dr. Lenkeit requests deferred to future Board meeting as Psychologist has not responded and Dr. Lenkeit needs to discuss case further with Ms. Bradley.
- I. **Complaint # 17-1024** – Dr. Ghezzi upon review felt that the Licensed Behavior Analyst was caught in the middle of the ethical guidelines and the company for which the LBA worked. The LBA took all reasonable steps to take care of the matter but was unsuccessful. The company is not bound by the ethical guidelines nor the states rules and regulations. Dr. Ghezzi recommends for dismissal. Ms. Becker made a motion to dismiss, with Ms. Bradley contacting company to inform them of the rules and regulations regarding termination of treatment and to cc Aging and Disability so that they are aware this may need to be a new regulation when they begin to govern the practice of Behavior Analysis; Dr. Wood-Antonuccio second; Board 5-0-0.
- J. **Complaint # 17-1025A** – Deferred to Future Board meeting so that Ms. Bradley could have more time to review the Complaint and Response. Dr. Krogh made a motion to defer this Complaint to MS Bradley so she draft a letter; Ms. Wood second; Board 5-0-0
- K. **Complaint 17-1025B** – Deferred to Future Board meeting as there is an ongoing investigation. Ms. Bradley's office is going to take over this Complaint. Dr. Krogh made a motion to defer to Future Board meeting; Dr. Wood-Antonuccio second; Board 5-0-0
- L. **Complaint 17-1109** - Deferred to Future Board meeting as there is an ongoing investigation. Ms. Bradley's office is going to take over this Complaint. Dr. Krogh made a motion forward to DAG for further review and action; Dr. Wood-Antonuccio second; Board 5-0-0.
- M. **Complaint # 17-1117**- Upon review of the complaint, Dr. Lenkeit stated that in his investigation he did not find any proof that the psychologist divulged any inappropriate information to the patient. Dr. Lenkeit recommends for dismissal. Dr. Wood-Antonuccio made a motion to dismiss; Dr. Krogh second; Board 5-0-0
- N. **Complaint # 1131** – Complaint was forwarded to Dr. Lenkeit. Defer discussion until a future meeting.

**11. Review and discussion of 2016-2017 audit completed by Kohn and Company**

Beth Farley, the accountant that completed the Board's audit, went over the financial highlights and stated that the Board's net revenue decreased by \$32,742 during the current fiscal year; the Program revenue for the fiscal year ended June 30, 2017, and was \$185,646 representing a \$15,840 increase from the fiscal year ended June 30, 2016.

Ms. Farley discussed the Statement of Net Position and Governmental Fund Balance Sheet, Expenditures and Changes in Fund Balance Sheet, Financial Notes, Equity Classifications, and Pension New Rules. With regard to the Board's Budget to Actual, she stated with regard to the budget cash basis the Board was over budget.

Ms. Farley went over the Internal Control Over Financial Reporting, and that due to limited staff and a lack of segregation of duties, proper oversight and review by the Board is necessary. She discussed with the Board that approval procedures were not in place. She suggested that Ms. Gleich received some training in oversight and perhaps the Board appoints someone to review monthly the accounting process with QB Online.

Discussion was held regarding the need to hire a part-time bookkeeper that has worked with other Boards and understands the accounting processes required. Dr. Paul questioned whether or not it was in the budget to be able to afford a **part-time** bookkeeper.

Ms. Farley suggested that perhaps she can spend at least one hour with Dr. Owens and Ms. Gleich to go over the Balance Sheets and was is acceptable.
