2. Public comment

    No public comment.

3. Approval of minutes of previous meetings.

    Dr. Carro moved to approve the minutes from the August 24, 2012 meeting as written. Dr. Parry second. Board vote 6-0-0.

4. Treasurer's report.

    Dr. Parry gave an update on the Board's finances. The Board's bank balance as of October 5, 2012 is \$88,797.43. Air travel expenses were high in the month of September due to Board training in Las Vegas. With renewals starting to come in, the Board should see the account increase; licensing fees are the Board's main source of income. Dr. Carro moved to approve the treasurer's report. Dr. Ghezzi second. Board vote 6-0-0.

5. Review of complaints, disciplinary actions, and litigation pending.

    a. Complaint #09-0409: Complaint was deferred until next meeting due to lack of response.

    b. Complaint #11-0322: In the process of setting up an evaluation. Complaint was deferred until next meeting due to Ms. Bradley being absent.

    c. Complaint #11-0928: Dr. Young stated that the interactions for this complaint were happening between Ms. Bradley and the complainants' attorney. Complaint was deferred until next meeting due to Ms. Bradley being absent.

    d. Complaint #12-0110: Dr. Carro stated Harry Ward is working on a proposed settlement.

    e. Complaint #12-0510: Complaint not assigned

    f. Complaint #12-0627: After review of complaint and discussion with the Clark County Public Defender's office Dr. Lenkeit recommends for dismissal. Dr. Parry moved to dismiss complaint with Dr. Lenkeit to send a letter to notify the complainant and the psychologist in question. Dr. Carro second. Board vote 5-0-1

    g. Complaint # 12-0725: Dr. Young upon review of the complaint found that there was no support of the allegations and recommends for dismissal. Dr. Ghezzi moved to dismiss. Dr. Parry second. Board vote 4-0-2.

    h. Complaint #12-0827: Deferred until the next meeting because Dr. Lenkeit has not yet reviewed the complaint.

6. Update regarding complaint for Injunctive Relief filed against David Hooper in the Eighth Judicial District Court.

7. Schedule of future Board meetings, hearing, and workshops.

The sub-committee for Behavior Analyst test development will meet on December 7, 2012 at 9:00 a.m. to evaluate the November 16 exam.

8. Board needs, operations, and schedules.

a. Update on renewal:

Ms. Alldredge updated the Board on the progress of the 2013-2014 renewals, which were sent out September 24, 2012. As of the day of the meeting there were approximately 20 renewals, and no requests for CE extension.

b. Request to have Sarah Bradley, DAG review related statutes:

During Board discussion, Dr. Lech noted the history of change in the title of psychologists and recommended discussing with previous Board members. Dr. Parry moved to have the Board formally request Ms. Bradley to review all the related statutes that pertain to the title and practice of psychology within the state of Nevada. Dr. Carro second. Board vote 6-0-0

c. Designate review for CE extension requests:

Dr. Parry volunteered as secretary/ treasurer to review all CE extension requests.

d. Discussion of hiring a Lobbyist for 2013 State Legislator:

The Board discussed the importance of hiring a lobbyist. Ms. Alldredge shared an estimate the Board had received for the previous session, of \$15,000.00 to hire a lobbyist. Dr. Parry moved to have Ms. Alldredge create an RFP with Dr. Lenkeit's assistance to find a lobbyist. Dr. Carro second. Board vote 6-0-0.

9. Continued discussion of ASPPB oral interview requirement to be given before the psychology State Exam.

After discussion the Board agrees there are other avenues for reciprocity. Dr. Parry moved to have the Board drop reciprocity through ASPPB mobility program. Dr. Neighbors second. Board vote 6-0-0

10. Review/discussion of behavior analyst exam.

The sub-committee chose 45 questions from a question pool, including some new items that need to be reworked, to make up two separate exams. They increased the degree of difficulty by adding another option to each question. Election of the chair will take place at the December 7, 2012 meeting.

11. Discussion of Board expectations regarding CABI training logs.

The sub-committee meeting is scheduled for October 15, 2012 at 10:30 a.m., where they will discuss approving CABI training programs rather than trainees.

12. Discussion of how to proceed with psychological assistants and PLUS system.

Ms. Alldredge informs the Board that ASPPB is expanding the PLUS system to include PA which will even more streamline the process. Dr. Neighbors moved to begin accepting PA applications via the PLUS system. Dr. Parry second. Board vote 6-0-0

13. Discussion and review of psychology State Exam.

Ms. Alldredge reports the exam was August 16, 2012 and had 26 applicants take the exam and had 23 applicants pass the exam. There will be a focus group on October 11<sup>th</sup> and 12<sup>th</sup> to develop and evaluate the psychologist exam.
