2. Public Comment

3. Approval of minutes of previous meetings.

Dr. Young moved to approve the minutes from the July 27, 2012 as written. Dr. Parry second. Board vote 6-0-0.

4. Treasurer's report.

Dr. Parry gave an update on the Board's finances. The Board's Bank balance as of August 24, 2012 is \$94,941.04. Currently the Board is staying within in the \$10,000.00 a month budget. There was an increase in professional services in the month of July due to the evaluation done for Complaint 09-0409. Dr. Carro moved to approve the treasurer's report. Dr. Young second. 5. Review of complaints, disciplinary actions, and litigation pending.

- A. Complaint #09-0409: Ms. Bradley presented the evaluating panel's recommendations to the Board. Stating under NRS 622.330, the Board is allowed to make an anonymous settlement agreement with a professional. The Board would recommend that the psychologist stay in treatment with current pain management physician, the Board would be allowed to review all drug screenings done by pain management physician, with updated prescription reports, per Board's requests. Dr. Lenkeit requests that Ms. Bradley add a provision of repayment for the costs that Board has paid in investigating this case.
- B. Complaint #11-0210: Dr. Ghezzi, the investigating Board member was absent for the vote on July 27, 2012, to approve the settlement agreement went on record that he would have abstained from the vote. Final order will be sent to Dr. Lenkeit to review and sign.
