2. Public Comment

3. Approval of minutes of previous meetings.

Ms. Bradley informed the Board that there is an evidentiary meeting in place for September 10, 2013, and that in the interim there is a temporary restraining order in place restricting David Hopper from performing psychological practices.

A: Discussion of 2013 State legislature

No discussion warranted.

B: Discussion of LCB File No R139-10

Dr. Lenkeit informed the Board that this was the discussion of custody evaluators and coordinators that was presented to the public in 2010. Ms. Bradley placed on the agenda to inform the Board that a bill is no longer eligible for action due to the two year limit on getting regulations passed.

C: Discussion of Non-Resident Consultants using Skype/Video Conference for therapy.

Dr. Young request item placed on agenda after reviewing a recent application for Non-Resident consultant. Dr. Lenkeit informed the Board that as this is a growing issue, ASPPB is looking into an "E-Passport" to allow people to conduct service telephonically. After discussion it was stated that a letter should be written to the Non-Resident consultant applicant, informing him of the weaknesses of using Skype as a therapy tool.

9. Discussion and decision regarding changing Board Structure by creating and appointing sub-committees to handle specific areas of Board Business. Proposed changes include creating subcommittees in the areas of applicants, legal, and executive with more specific duties to be discussed and assigned.

Dr. Lenkeit reintroduced the change of format to the Board. The Board discussed issues with the change of format, worry of "rubberstamping", of an individual Board member being over worked, committees being unbalanced and the issues with technology and open meeting law. Ms. Bradley informed the Board that if the full Board gives authority to the committees then the committee can make decisions on items without having to bring said item back to the full Board for approval. Ms. Becker requested that the sub-committees be described in further detail to understand what these committees will be doing, and to work out the figures of cost for this new structure, with additional travel. Further information will be presented at the next Board meeting.

10. Discussion and decision regarding policy for addressing unlicensed activity which may include a discussion regarding implementation of NRS 641.2705 by the board.

Ms. Bradley presented to the Board the various types of actions a Board can take against persons practicing psychology without a license. She suggested that the Board office assign a complaint number to all notifications of unlicensed activity received, so the Board can track the activities. If needed, cease and desist orders need to be completed at the full Board meetings.

Ms. Bradley suggests that the Board first send a warning. If after the warning there is proof of continued practice the Board can send a citation. Dr. Lenkeit stated that the Board needs to formalize the process to deal with unlicensed activity. Ms. Alldredge and Dr. Lenkeit will come up with a process to be discussed at a future Board meeting.
