## Public Workshop 10:00 a.m.

#### Public Workshop of R127-14

Call to order at 10:00 a.m.

Ms. Alldredge informed the Board that the new language for the EPPP restrictions was incorrect. Ms. Bradley and Ms. Alldredge will work on correcting the language. Dr. Paglini felt the Board should not interfere until after three failed attempts at the exam, and then close the file after 4 failures. Dr. Paul suggested stating that, "Unless otherwise approved by the Board the applicant's file is closed" rather than just closing the file. Dr. Paul moved to amend the language to allow an individual to fail the exam three times, for the fourth attempt the individual must

submit a study plan to the Board, beyond four times, unless otherwise approved by the Board, the application is closed. Dr. Paglini second. Board vote 7-0-0

Ms. Alldredge read in a public comment from Dr. William Brandon stating his concern over restricting the numbers of CABIs that may be supervised. Julie Kotchevar presented concern over the wording of the change to the supervision restriction, stating that the number significantly limits ATAP's capability to provide services. Ms. Kotchevar informed the Board that with this regulation change, BCBAs may choose to not practice in Nevada, while Psychologists will not want to participate in the Behavior Analysis supervision.

Dr. MacAleese informed the Board that limiting the supervision number could affect the rural areas. Dr. MacAleese also presented the concerns over the renewal for CABIs as not only do CABIs have to pay their renewal fees, but also have to pay to travel for the required Continuing Education hours, and that the requirement of 40 hours in place of the direct service hours seems to be too high. Dr. MacAleese asked that the Board consider a reduction of CABI fees as well as think about any future practice acts.

 $\,$  Dr. Elaine Brown requested that the limitation of supervisees wait until coverage by Medicaid is decided on.

Dr. Shannon Crozier informed the Board that issues may arise with the limitation due to the way that teams are organized. Dr. Crozier informed the Board, that due to the amount of part-time employees, that there would be no way to formulate an affective team. Dr. Paul reiterated the purpose of the language change in regard to Behavior Analyst supervision is because in its current form the Board found it difficult to regulate and enforce. Dr. Paul suggested the Board consider changing the language to state "Full-Time Equivalent." Justin Kyrrianis, Erik Lovaas, and Charles Marriott also stated issue with the supervision restriction.

Jan Crandy informed the Board that by restricting the number, many people will not want to participate and the service will diminish.

Dr. Lenkeit tabled any further discussion of R127-14, and requested that all Board members review the comments from the public, and bring language changes to the November 7, 2014 Board meeting. Dr. Paul asked that the public submit suggested changes, with the rationale behind the changes, in writing to the Board office by October 25, 2014.

## Public Workshop of R128-14

Call to Order at 11:18 a.m.

Ms. Bradley updated the Board about the changes to this regulation. Mr. Hal Taylor presented the concern in regard to the consultant language, stating that in the language it could be interpreted as the Board qualifying individuals as experts, by granting them the ability to participate in court. Ms. Bradley suggested add "in conjunction with an evaluation or about an evaluation that you did on a Nevada Citizen."

Mr. Taylor also presented concerns with the language regarding evaluators for mental health exams, as three evaluators equals triple the cost. Ms. Bradley informed the Board that this was added due to the fact that it was also present in NRS, and that it was placed in NAC to give the Board the authority to evaluate Licensed Behavior Analysts, Licensed Assistant Behavior Analysts and Certified Autism Behavior Interventionists as well as Psychologists. Mr. Taylor suggested changing the language to state professional competence rather than mental competence.

Dr. MacAleese vocalized his concern that there is no practice act, and thereby the Board has no authority over those who are not licensed by the Board.

There will be a public hearing on November 7, 2014.
