NOTICE OF INTENT TO ACT UPON A PROPOSED REGULATION 127-14
Notice of Public Hearing for the adoption/amendment regulations of the State of Nevada
Board of Psychological Examiners

The State of Nevada Board of Psychological Examiners (Board) will hold a public hearing at 9:30a.m., on Friday, January 15, 2016, through Video Conference to University of Nevada, Las Vegas, 4505 S. Maryland Pkwy. CBC B-117, Las Vegas, NV 89154 and to University of Nevada, Reno Knowledge Center Room 110, Reno, Nevada 89557. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulation that pertains to Chapter 641 of the Nevada Administrative Code.

R127-14 relating to the Board of Psychological Examiners; revising provisions relating to certain requirement for licensure as a psychologist; repeal provisions relating to the certification and supervision by the Board of certified autism behavior interventionists; revising provisions relating to the supervision of an autism behavior interventions; revising provisions relating to the nation and state examinations required for licensure as a psychologist, licensed behavior analyst and licensed assistant behavior analyst; revising provisions relating to certain fees charged by the Board for certain services; revising the scope of practice for a psychologist; repealing certain provisions relating to areas of acceptable practice of psychology and specialization; repealing certain provisions relating to certification, continuing education and scope of practice for certified autism behavior interventionists; and providing other matters properly relating thereto.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The proposed amendment is necessary to establish Board policy and to clarify existing Board policy.
2. This notice and additional copies of the regulation have been posted at 4600 Kietzke Lane, Bldg B-116, Reno for inspection by members of the public during business hours. Additional copies of notice have been posted in all counties in which an office of the agency is not maintained, at the main public library or county office. This notice and regulation which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the internet at <http://www.leg.state.nv.us>. Copies of this notice and regulation will be made available on our web site at <http://psyexam.nv.gov> as well as mailed to members of the public by request. A reasonable fee may be charged for copies if it is deemed necessary
3. The Board does not believe that the proposed amendment will have a direct economic effect on the business of the practice of psychology, behavior analysis or the public.
4. Enforcement of the proposed amendment will not result in an increased cost to the Board.
5. To the Board's knowledge, the proposed amendment does not overlap or duplicate the regulation of other state or local governmental agencies or any federal regulations.
6. The proposed regulations do not establish new fees or increase existing fees.

Persons wishing to comment upon the proposed regulation of the Board may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Board 4600 Kietzke Lane B116, Reno Nevada 89502.

Written Submissions must be received by the State of Nevada Board of Psychological Examiners on or before **January 11, 2016.**

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within the 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against the adoption.
