2. Public Comment

3. Approval of minutes of previous meetings

Dr. Ghezzi moved to approve the Friday, February 26, 2016 minutes as submitted. Ms. Becker second. Board Vote 5-0-0.

7. Board Policies and Procedures regarding the registration of Psychological Interns.

A. Approval process for Psychological Interns

Ms. Alldredge introduced the new Intern List, which allows us a better way to monitor applications for registration. It was decided that the Board does not have to monitor hourly logs for the interns. Ms. Becker motioned to approve this new Intern List. Dr. Ghezzi second. Board Vote 6-0-0.

8. Schedule of future Board meetings, hearings, and workshops.

The next Board meetings are April 29, 2016, and June 10, 2016 at 9:00am. Ms. Alldredge also reminded the southern Board members to be prepared to possibly come to the hearing on April 29, 2016, if that goes forth.

9. Board needs, operations, and schedules.

A. Notice Nevada Medicaid of LBA Scope of Practice

Ms. Bradley stated that it may be appropriate for the Board to send a letter to Medicaid. Dr. Lenkeit asked that Ms. Bradley and Ms. Alldredge put together a draft for Dr. Lenkeit to review prior to sending out. Ms. Becker moved that the Board send a letter to Medicaid stating the scope of practice for LBA's. Dr. Young second. Board Vote 6-0-0.

10. Update regarding changes to NAC 641.

A. R127-14 - There were no updates.

B. R128-14 - Ms. Bradley reported items that were added for disciplinary procedures for LBA's, such as is in place for psychologists, also items cleaning up all items with CABI. A Public Hearing will be scheduled for 4/29/15.

C. R131-15 - Dr. Paul reported on the sub-committee meeting and stated that because of a misinterpretation, a revision had to be made, but they have not received that back. Dr. Trybus from Walden University had submitted a suggested change to R131-15 at the last Board meeting regarding education evaluation. The revision provides Non-APA applicants the option for either the Director or Chair of an APA program or ASPPB be the entity to evaluate the equivalency. Ms. Bradley read NRS 641-170(1)(d), which states the standards the Board must adhere to, which was put into place in 1987. Ms. Alldredge states that CARS, which is the ASPPB approval process, is a four person process in which the Board will use to check equivalency. Ms. Bradley also suggested a consideration, when an applicant is denied, to have a more codified process of appeal. Mr. Taylor spoke in regard to what the legislation currently is and encouraged the Board to continue to follow that. Mr. Maul stated that he agreed with the language that Mr. Trybus used, of allowing both options for the applicant. Dr. Paul asked about the legal liability of a single person reviewing equivalency. Ms. Bradley cited NRS 641.318 which covers immunity of certain persons concerning civil liability.

Dr. Young made a motion for Ms. Bradley to draft an amendment that would define the appeal process for reconsideration when an applicant is denied. Dr. Paglini second. Board Vote 6-0-0.

Dr. Paul motioned to approve the amendment as proposed by Dr. Trybus in its' entirety. Pam Becker second.

Board Vote 4-1-1.

D. R038-16 - Ms. Alldredge worked on language for Intern standards and it has been submitted to LCB. Dr. Trybus had one concern raised in regard to "substantially on-line" language and requested that be struck. However, since the language had not been received back from LCB further discussion of this language change was tabled.

12. Further discussion regarding email sent from Chaz Rainey

Ms. Bradley advised the Board to only respond to questions pertaining to NAC 641. She specifically stated questions 10, 11 and 12 and possibly 5. Dr. Lenkeit stated a possible response to question 5 - Psychologist must work within NRS 641/NAC 641 and APA guidelines and non-licensed persons are unable to direct treatment; and question 2 - The Board doesn't license corporations; while registration is in statute it is not currently enforced. The answers to questions 2 and 5 will be sent and Ms. Bradley will work on a draft for the rest to be presented to the Board at the April meeting.

13. Discussion and decision regarding Elysse Kompaniez-Dunnigan

Dr. Lenkeit updated the public regarding the history of the education plan. Dr. Young presented the committee's review process with the Board approving a re-specialization program. Mr. Taylor presented Dr. Kompaniez-Dunnigan's process and requests the Board to complete the motion that was made in October. Dr. Lenkeit recommended that we send to ASPPB for review. After a long discussion, Dr. Paglini motioned that we send to ASPPB for review of program. Dr. Paul second. Board Vote 6-0-0.

14. Update regarding requested Attorney General Opinion for clarification of NRS 432B.040.

Ms. Bradley reported that a draft was written and waiting for final approval. Ms. Bradley will mail to Ms. Alldredge for review to Board members before the April Board meeting.

15. Discussion and Clarification of NAC 641.219

Dr. Paglini reported that record retention according to APA guidelines is 7 years, yet our NAC 641 regulations state 5 years for healthcare records. It was stated that the court is the actual client, therefore, would 7 years meet the court retention schedules. Ms. Bradley will find out what the Court retention record regulations are. Ms. Bradley recommended an amendment to NAC 641 to match the APA guidelines and to specific forensic verses healthcare. Ms. Bradley and Ms. Alldredge will come up with language suggestion for the next Board meeting in April 2016.

16. Correspondence**A. Timothy Sinnott: Clarification of LBA scope of practice**

Ms. Alldredge suggests that the Board work on clarification of the scope of practice in the regulations. There was a discussion about scope of practice for LBA. It was decided he may provide the services in his email, anxiety disorders, depression, ADHD, sleep disorders and autism, as long as there was an initial autism diagnosis.

Mr. Nick Nicosia began to make a public comment on a complaint that is pending before the Board. Ms. Bradley had to stop Mr. Nicosia because the complaint is still under review.
