2. Public Comment

3. Approval of minutes of previous meetings

Ms. Becker moved to approve the Friday, March 25, 2016 minutes as submitted. Dr. Wood-Antonuccio second. Board Vote 7-0-0.

4. Treasurer's report

Dr. Young reported that the Board continues to maintain the increase in income, due to exam fees and biennial fees coming in on a monthly basis. Executive Assistant's computer was purchased for \$239.00 from Office Depot. An external hard drive was also purchased to back up each computer. Board staff, Board salary and lobbyist costs were highest in April. The Board office costs continue to run between \$10,000.00 and \$12,000.00 monthly. Dr. Young reported that we may be able to save costs, by not utilizing an auditor on non-renewal years, as long as the Board's income remains below \$75,000.0. Our income for the current Fiscal year is \$49,977.88. The fiscal year runs from July-June. We received a \$128.00 reimbursement from State Farm for 2015 Workers Compensation. Dr. Young reported that the bank balance is \$88,884.33. Dr. Ghezzi motioned to approve the report. Dr. Wood-Antonuccio second. Board Vote 7-0-0.
