2. Public Comment

3. Approval of minutes of previous meetings:

- D. **Complaint # 17-1109** - Dr. Young is still investigating as it is related to above
- E. **Complaint # 17- 1131** – This case is being assigned to Dr. Lenkeit, Investigator. Requests deferred to future Board meeting.
- F. **Complaint # 17-1214** – Ms. Bradley still working on a Settlement Agreement

- G. **Complaint # 17-1221** – Received from citizen advocacy. Psychologist practiced in CA and maintained license in Nevada. All correspondence to the Psychologist has been returned. Ms. Bradley is going to investigate and make sure we have a record on file.
- H. **Complaint # 18-0123** – Requests to combine both H and I. As they are filed by separate parties against the same psychologist with similar accusations.
- I. **Complaint # 18-0124** Dr. Lenkeit, Investigator, stated that the Psychologist that is the subject of the complaint is not currently licensed in Nevada, but works for the Department of Corrections, and has an open application for licensure. Complaints by two individuals who are inmates, and were convicted of sexual assault. Both Complainants raised issues with the Static-99, as the questions are biased against their lifestyle. Psychologist noted that as an instrument for measurement is required by the Nevada Parole Board, the Static 99 is only one reason out of five reasons for parole denial. Dr. Lenkeit recommends dismissal of both Complaints. Dr. Paglini noted that the Static-99 is an accurate instrument based on the statistics and no bias. Dr. Lenkeit will do a write it up and provide at next Board meeting.

Dr. Wood made a motion to dismiss both cases; Dr. Paglini second; Board 4-0-0

Board staff requests that the Order be amended on page two, paragraph D to indicate that licensed psychologist Dr. Shera Bradley will provide clinical supervision of Dr. Dennis as ordered by the Board.**

Dr. Dennis originally named Dr. Dan Shiode to be Dr. Dennis' clinical supervisor, and the Board approved it. Dr. Shiode could not do it. Dr. Lenkeit was given the task to find a new Supervisor and he found Dr. Shera Bradley. She has agreed to supervise but requested settlement be voted on and updated by the Board. Dr. Wood moved to accept the change, Ms. Becker second; Board – 4-0-0
