Meeting Minutes

June 2, 2023

1. Call to Order/Roll Call to Determine the Presence of a Quorum.

Call to Order: Committee Chair Soseh Esmaeili called the Nevada Board of Psychological Examiners' Application Tracking Equivalency and Mobility ("ATEAM") Committee to Order on June 2, 2023, at 10:13 a.m.

Roll Call: Committee Chair, Soseh Esmaeili, Psy.D., and Committee Member, Dr. Stephanie Holland, Psy.D., were present. Committee Member, Dr. Catherine Pearson, Ph.D., was absent. Despite Dr. Pearson's absence, the Committee had a quorum.

Also present was Laura M. Arnold, the Board of Psychological Examiner's Executive Director.

a. Melissa Stolsig

Dr. Melissa Stolsig's Application was reviewed by Dr. Holland and Dr. Esmaeili. There were no concerns present. Dr. Holland noted that the program was not accredited but accredited 4 years after Dr. Stolsig's attendance. Submitted with Dr. Stolsig's Application was a letter from the program which provided that the data selected for APA accreditation was used from when Dr. Stolsig was a student. Accordingly, Dr. Holland and Dr. Esmaeili believe the Application is straightforward. Dr. Esmaeili reviewed the coursework which seemed to meet criteria and aligned, which resulted in Dr. Esmaeili recommending that the Board approve Dr. Stolsig's Application.

On motion by Stephanie Holland, second by Soseh Esmaeili, the ATEAM will recommend to the Board approval of Dr. Melissa Stolsig's Application for Licensure. (Yea: Soseh Esmaeili, Stephanie Holland.) Motion Carried: 2-0
