Ms. Bradley provided some history and explanation in regard to these suggested changes.

Mr. Taylor requested clarification regarding the language on page 13 and 14 discussing an expert witness. Ms. Bradley responded that the reason for the change is to ensure that an individual who enters the state who intends to talk to or evaluate a person currently in Nevada registers with the Board. It was recommended to place a notice to Nevada lawyers about the Non-Resident Consultant language changes.

One would be the surrender of the psychologist's license. The other option would be to submit to a psych evaluation. Ms. Bradley clarified that if the license is surrendered it would be reported to the National Databank, stating that the license was surrendered without any admissions. ## **6. Update regarding complaint for Injunctive Relief filed against David Hopper in the Eighth Judicial district Court.**

Ms. Bradley updated the Board on the order made at the November 6, 2014 Hearing. The permanent injunction was granted as well as the Board's request 1-4. Ms. Bradley is going to try and include in the final order that Mr. Hopper will pay Board costs and attorney fees. The final order will not be ready for at least 2 months due to various administrative and Legal requirements. Ms. Bradley informed the Board that the order should be placed on the website, as well as a possible press release on the final decision so that the public will know.

## **7. Schedule of future Board meetings, hearings, and workshops.**

### **A. Discussion of January Board Member Training**

The next Board meeting will be December 12, 2014 at 9:30 a.m. by teleconference. ### **A. How to handle new licensees/Certificate Holders and Renewals.**

Ms. Alldredge requested from the Board the possibility to allow new licensees to pay their 2015-2016 Renewal fees along with their new licensing fees. Dr. Young informed the Board that this was a good plan as their Continuing Education would be waived for the first renewal. Dr. Young moved to allow the Board office to allow new licensees to renew for 2015-2016 at the same time as paying their initial licensure fees. Dr. Wood-Antonuccio second. Board vote 7-0-0

### **B. Developing relationships with Local Professional Associations.**

Ms. Alldredge informed the Board of the need to create a working relationship with the Board and both the Nevada Psychological Association and the Nevada Association for Behavior Analysts. Dr. Lenkeit informed the Board that he met with the president of the NPA who appeared receptive of the idea and will present it to her Board. Dr. Ghezzi felt that NABA will also be interested in this concept. Ms. Alldredge suggested creating a liaison who would attend both NPA and NABA meetings, as well as someone from their Associations who would attend Board meetings. Dr. Lenkeit said that this would be a struggle as many of their meetings are at the same time as the Board's meetings. Along with liaisons, the Board would request to have time to present Board business and have an active Q and A at both Associations annual meetings. This will allow for a more open relationship between the Board and its licensing public. Ms. Alldredge will report back on this idea at the December 12, 2014 meeting.

**11. Update regarding R111-13.**

**A. Discussion of application process for Psychological Interns**

Ms. Bradley informed the Board that R111-13 has been passed by the Legislature and the Psychological Intern language is now official. Ms. Alldredge requested that one or two of the Board members help develop an application and process for the inter level. Dr. Paul and Dr. Young volunteered to help Ms. Alldredge develop all the needs. Dr. Wood-Antonuccio moved to allow Dr. Paul, Dr. Young and Ms. Alldredge develop the Psychological Intern application and required processes. Dr. Ghezzi second. Board vote 7-0-0

**12. Review and Discuss language changes to R127-14.**

Ms. Alldredge updated the Board on the change of language for the EPPP limitation. The language will now state that the applicant may attempt the exam twice. Upon the third attempt the applicant must submit a written study plan to the Board for approval. After the fourth failed attempt, the application is closed and the applicant may not reapply for 18 months, and only reopen with approval of the Board. Dr. Young moved to approve the new language. Dr. Paglini second. Board vote 7-0-0

Ms. Alldredge presented to the Board, based on the discussion from the last Board meeting, the suggested language change to remove Licensed Assistant Behavior Analysts from the limitation and state that a supervisor may supervise 14 fulltime equivalent CABIs, but no more than 20 unless approved by the Board. Dr. Paul recommended the Board, that after she had an extensive conversation with Dr. Shannon Krozier, the Board should move away from a strict number of supervisees and follow BACB's guidelines which states that, "It is the Supervisor that is required to provide 1 hour of supervision per every 10 hours of direct service." Dr. Krozier noted that the the Behavior Analyst Certification Board states unequivocally that they do not place a limit on supervisees. Dr. Krozier recommended following BACB's guidelines verbatim. Ms. Alldredge requested that this change to the language would be hard to monitor within the Board office, which was the initial reason to change the language. Ms. Becker informed her that this discussion would be better at a later date. Ms. Becker moved to change the verbage [of section 4] to match that which is in BACBs guidelines on page 31 of their publication. Talking about case load size. Dr. Paul second. Dr. Ghezzi pointed out that case loads and supervisees are very different and opposed the suggested change stating that it did not meet the goal which the Board originally set out to do. Board vote 6-1-0

Ms. Bradley responded that on the state level, a client could only refer to the licensing board that the hypnotherapist was licensed under, if any. In response to this, Dr. Young asked if the client could report the complaint to the Hypnotherapy Union. Mr. Bud James informed the Board that the code of ethics is taken very seriously by the National Hypnotherapy Board, and that a client with a complaint could report the Hypnotherapist to the Union or to the Better Business Bureau. Mr. Taylor informed the Board that he has recommended that the Hypnotherapists push for legislation placing them underneath a licensing Board, but currently it is too late for any legislation. Dr. Paul moved to withdraw the Cease and Desist letters in order to move forward with legislation for Hypnotherapy. Dr. Wood-Antonuccio second. Board vote 5-0-0

Ms. Bradley informed the public members in attendance that the withdrawal of the Cease and Desist letters will be effective November 7, 2014.
