2. Public Comment

3. Approval of minutes of previous meetings.

Dr. Lenkeit suggested a correction to item 5(c) in the March 2, 2012 meeting minutes. Dr. Parry moved to approve the minutes with Dr. Lenkeit's correction. Dr. Young second. Board vote: 6-0-0.

4. Treasurer's report.

Dr. Parry informed the Board is currently operating over the \$10,000 per month budget. The current account balance is \$126,027.27. The Board discussed the cost of the State Exam for psychologists and behavior analysts, noting the Board was losing money on each psychologist exam. Board members requested an item analysis on exam expenditures, to be presented at the next meeting. Dr. Lenkeit also requested that an analysis of budgeted versus actual costs be included in the next treasurer's report. Dr. Carro moved to accept the treasurer's report as submitted. Ms. Alldredge updated the Board on the new computer purchase and the development of the new Board website. Ms. Alldredge and Ms. Saltus requested the Board's approval to close the office on July 5, 2012. The Board approved to close the office on July 5, 2012.

9. Continued discussion of ASPPB oral interview requirement to be given before the psychology State

Dr. Neighbors informed the Board that the subcommittee will be meeting soon to discuss the questions and will present the outcome at the Board at the next meeting.

10. Review/discussion of behavior analyst exam.

Dr. Parry informed the Board that the sub-committee was successful in revising the exam for the May 18, 2012, exam. The Board discussed conflicts with proctors for the exam.

11. Discussion of  $27^{\text{th}}$  Midyear ASPPB Meeting in New Orleans, April 12-15, 2012.

Dr. Young informed the Board of the main topics discussed at the meeting. There was lengthy discussion regarding telepsychology with recommendations on how to handle the subject in a more unified manner among jurisdictions. There was also a presentation by APA on accreditation of doctoral and internship sites. Ms. Alldredge was invited to attend the Board Administrators and Registrars committee prior to the meeting. She informed the Board that, during the meeting, she acquired multiple ways to improve Board meetings and productivity within the office. Dr. Parry requested that these items be discussed at a future Board meeting.

12. Discussion/decision to participate in the ASPPB PLUS licensing system.

Dr. Lenkeit and Dr. Young expressed interest in participating in the ASPPB PLUS system. Dr. Parry expressed concerns over the cost of the system after the pilot phase. Dr. Young informed the Board that the Board is not required to continue with the program after the end of the pilot phase. Dr. Carro added that the centralized and uniformed nature of the application process is good for the public as well as the applicants. Dr. Young moved to participate in the ASPPB PLUS pilot program. The Board discussed the possibilities of moving the exams online. The Board also discussed ways in which to reduce spending on the exams.

Dr. Mahaffey provided the Board with exam statistics for the Psychology State Examination results over a period of two years. The Board discussed the nature of which types of questions should and should not be included on the state exam.
